Cheshire East Councillor Becky Posnett attended to update the meeting on issues affecting Cheshire East Council. The following points were raised: -

- Highways do meet with the team and kept updated on what is happening, but not communicated to the public all the time.
- Local Plan is going out for consultation soon and will include a call for sites element.
- Budget Cheshire East budget document is available online. Have had some support from central government.
- Issues some blocked drains and issues with Top Fam Lane.

206. HIGHWAY MATTERS/SPEED WATCH

The following matters were raised under this heading: -

 Road Warning Signs – bend between the Boot and Slipper junction and the Hickhurst Lane junction on Winsford Road – two occasions where the property has been damaged due to vehicles sliding on the bend. Issues being caused by mixture of wet road and mud on the road from different sources. The Parish Council **AGREED** to ask CE Highways to look at the situation.

- Further issue was raised regarding the narrow road at the bridge over the brook on Winsford Road and the need for a sign at the location.
- Hedges it was AGREED to contact property on Long Lane regarding hedges to ask that they are cut back, The Chair agreed to draft a letter to the resident.
- Grass Verges cutting of grass verges in the parish had been raised with the Parish Council.
